

**SHASTA-TRINITY NATIONAL FOREST  
FOREST ORDER NO. 14-21-31  
RIVER COMPLEX CLOSURE**

Pursuant to 16 U.S.C. § 551 and 36 C.F.R. § 261.50(a) and (b), and to provide for public safety, the following acts are prohibited within the Shasta-Trinity National Forest. This Order is effective from September 18, 2021 through November 15, 2021.

1. Going into or being upon any National Forest System lands within the River Complex Area Closure, as described in Exhibit A and shown on Exhibit C. 36 C.F.R. § 261.52(e).
2. Being on any National Forest System roads within the River Complex Area Closure, as listed in Exhibit B and shown on Exhibit C. 36 C.F.R. § 261.54(e).
3. Being on any National Forest System trails within the River Complex Area Closure, as listed in Exhibit B and shown on Exhibit C. 36 C.F.R. § 261.55(a).

Pursuant to 36 C.F.R. § 261.50(e), the following persons are exempt from this Order:

1. Persons with Forest Service Permit No. FS-7700-48 (Permit for Use of Roads, Trails, or Areas Restricted by Regulation or Order), specifically exempting them from this Order.
2. Any Federal, State, or local officer, or member of an organized rescue or fire fighting force in the performance of an official duty.
3. Owners or lessees of land in the River Complex Closure Area, to the extent necessary to access their land.
4. Commercial recreational special-use permit holders and their customers are not exempt from this Order. However, commercial recreational special-use permit holders, under the terms and conditions of their permit, may access their permit areas to conduct administrative functions and to protect property and related assets. Recreation residence permit holders are not exempt from this Order.

These prohibitions are in addition to the general prohibitions in 36 C.F.R. Part 261, Subpart A.

A violation of these prohibitions is punishable by a fine of not more than \$5,000 for an individual or \$10,000 for an organization, or imprisonment for not more than six months, or both. 16 U.S.C. § 551 and 18 U.S.C. §§ 3559, 3571, and 3581.

The River Complex Area Closure Area boundary begins at the intersection of Shasta-Trinity National Forest Boundary and Siskiyou County Line (Section 29, Township 41 N, Range 6 W, Mount Diablo Meridian (MDM)), then continues south along the southern edge of the Siskiyou County Line to its intersection with the western edge of Forest Road 42N17 (Parks Creek FA17) (Section 10, Township 40 N, Range 6 W, MDM), then continues south along the western edge of Forest Road 42N17 (Parks Creek FA17) to the intersection of Forest Road 40N45 (Bear Creek) (Section 15, Township 40 N, Range 6 W, MDM), then continues south along the west edge of Forest Road 40N45 (Bear Creek) to its intersection with the western edge of Forest Road 40N26 (South Fork FA26) (Section 23, Township 39 N, Range 6 W, MDM), then continues south along the western edge of 40N26 (South Fork FA26) to its intersection with the northern edge of Mumbo Creek (Section 35, Township 39 N, Range 6 W, MDM), then continues west along the northern edge of Mumbo Creek to its intersection with the western edge of Forest Road 39N25 (Whalen FA25) (Section 28, Township 38 N, Range 6 W, MDM), then continues south along the western edge of Forest Road 39N25 (Whalen FA25) to its intersection with the western edge of Forest Road 38N21 (Highland Lakes) (Section 27, Township 38 N, Range 6 W, MDM), then continues south along the western edge of Forest Road 38N21 (Highland Lakes) to the Shasta County Line (Section 11, Township 37 N, Range 6 W, MDM), then continues south along the western edge of the Shasta County Line to its intersection with County 118 (Slate Mountain) (Section 3, Township 36 N, Range 6 W, MDM), then continues south along the western edge of County 118 (Slate Mountain) to the intersection of County 106 (East Side Road) (Section 30, Township 36 N, Range 6 W, MDM), then continues north along the eastern edge of with County 106 (East Side Road) to its intersection with the western edge of East Fork Trinity River (Section 36, Township 36 N, Range 6 W, MDM), then continues south along the western edge of East Fork Trinity River to its intersection with the western edge of Trinity Lake (Section 1, Township 36 N, Range 6 W, MDM), then continues south along Trinity Lake to its intersection with the northern edge of Stuart Fork River (Section 34, Township 35 N, Range 9 W, MDM), then continues west along the northern edge of Stuart Fork River to its intersection with the southern edge of the Trinity Alps Wilderness Boundary (Section 18, Township 35 N, Range 9 W, MDM), then continues east along the southern edge of the Trinity Alps Wilderness Boundary to its intersection with the northern edge of the Shasta-Trinity National Forest (Section 7, Township 39 N, Range 7 W, MDM), then continues along the northern edge of the Shasta-Trinity National Forest back to the starting point, as shown on the attached map. 36.
