

Smoke Outlook for 10/01 - 10/02 Fresno CA - KNP Complex Issued at: 2021-10-01 07:36 PDT

Special Statement

Smoke infiltration from the Windy and KNP Complex fires in Tulare County combined with high pressure and poor dispersion have prompted air quality officials in the San Joaquin Valley to issue an Air Quality Alert. Smoke is expected to continue to impact the San Joaquin Valley through Monday, October 4.

Fire

The KNP complex is 51,596 acres and 20% contained. The fire remains active in some extremely steep, rugged, and remote areas. For more information see inciweb.nwcg.gov.


Smoke

Very light winds today, Visalia and nearby will reach unhealthy concentrations of smoke; Fresno will be unhealthy for sensitive groups. Air quality will be worse still in foothill and mountain areas near the wildfires. There may be hours of the day that are better or worse, but no significant relief is expected this weekend.
