Fire

The KNP Complex is 87,145 acres and 20% contained. Yesterday, precipitation limited fire behavior to creeping and smoldering. Today, expect low fire behavior with little forward fire progression. For more information see inciweb.nwcg.gov.

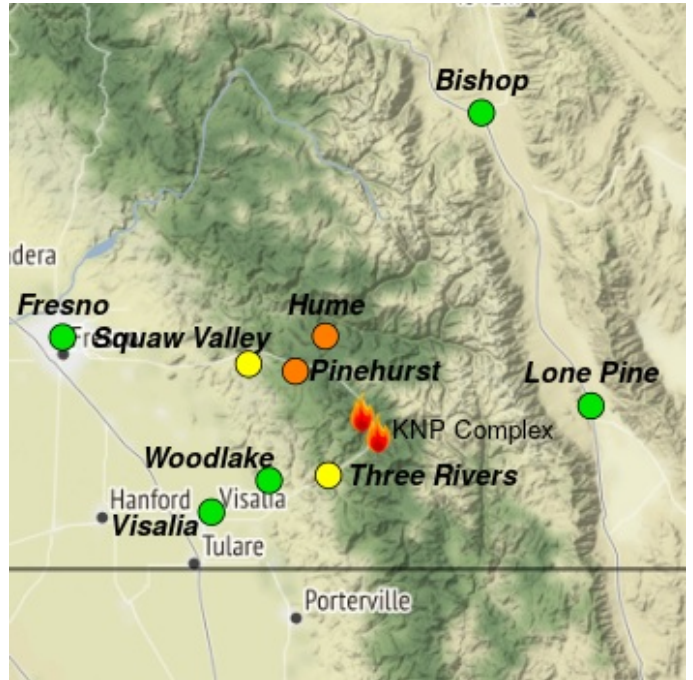
Smoke

Yesterday saw Good to Unhealthy for Sensitive Groups (USG) air quality in the forecast area. The Central Valley should see Good AQI while the foothill communities are forecasted to see Moderate AQI. Pinehurst and Hume Lake should see better smoke impacts than previous days, but due to the proximity to the fires, may still see degraded air quality. Smoke impacts will be heavily dependent on fire activity.

Health and Safety

Air quality may change unexpectedly. If you begin to notice health effects from smoke, you are encouraged to follow the "actions to protect yourself" listed below.

Air Quality Index (AQI)	Actions to Protect Yourself
Good	None
Moderate	Unusually sensitive individuals should consider limiting prolonged or heavy exertion.
USG	People within Sensitive Groups* should reduce prolonged or heavy outdoor exertion.
Unhealthy	People within Sensitive Groups* should avoid all physical outdoor activity.
Very Unhealthy	Everyone should avoid prolonged or heavy exertion.
Hazardous	Everyone should avoid any outdoor activity.
