

Fire

Hermits Peak Fire ~ Calf Canyon Fire combined is currently at 288,942 acres with 36% containment. Unseasonably warm temperatures with low humidity and light wind conditions will be observed today.

Smoke

All communities in the outlook area will experience continued smoke today with lighter winds and stable atmospheric conditions. Drainage winds continue for the outlook area, which will cause smoke to accumulate in the outlook area in the overnight and early morning hours. A weak cold front is forecast to cross eastern NM this afternoon into evening. Winds will shift to the SSW by mid day. Western highlands communities should experience USG and Unhealthy conditions in the morning with modest improvement for periods in the late morning until the WSW winds develop bring smoke back into those areas. The Las Vegas Valley will average Moderate through most of the day today. Mora will experience Unhealthy AQ this morning and USG conditions this afternoon. Rociada, Pendaries, and Buena Vista should experience USG conditions throughout the outlook period. Smoke draining along the NM 518 corridor forecast to bring smoke into the Taos Valley overnight.
