Eastern New Mexico - Hermits Peak-Calf Canyon-Midnight Fires

6/12 - 6/13

## Special Statement

RED FLAG WARNING is in effect for most of the area today and all areas tomorrow.

## Fire

Hermits Peak & Calf Canyon Fire is currently at 320,333 acres and 70% contained. The Midnight Fire is reported at 3,478 acres and 0% contained.

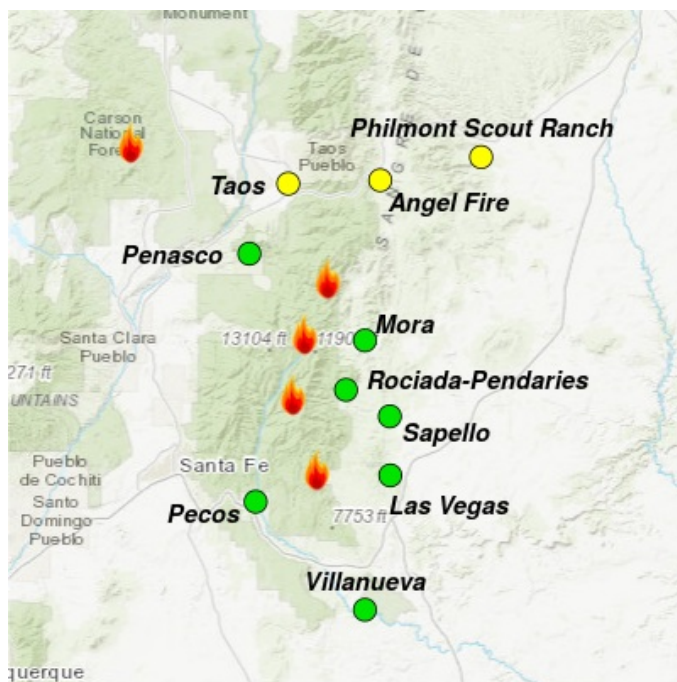
## Smoke

Smoke from the Midnight Fire will continue to impact Taos, Angel Fire, and Cimarron/Philmont Scout Ranch today, where levels could once again reach 'Unhealthy for Sensitive Groups'. Heaviest smoke will be in the afternoon and evening hours. Smoke from the Hermits Peak-Calf Canyon Fire will have 'Moderate' impacts to Las Vegas, Mora, Sapello, Rociada-Pendaries, and Villanueva but air quality should remain 'Good' overall. All forecast areas will likely see hazy skies.

Critical fire weather over the next few days can lead to an increase in fire behavior and smoke at any time. Stay alert to changing conditions!
