## CURRENT SITUATION

### Situation Summary:

Containment is risings as crews strengthen control lines. In the Devil's Gulch and Owl Creek area, control lines are holding and are being reinforced. Suppression repair efforts are underway in areas of the fire that are no longer posing a potential risk of escape. These repairs minimize potential soil erosion and impacts resulting from fire suppression activities. Today's temperature is forecast to be nearly the same as yesterday. Damage inspections are 100% complete.

**REMINDER:** Mariposa County is hosting a Local Assistance Center (LAC) for ANY community member who has been directly impacted by the Oak Fire. This includes those who are/were evacuated, have/had power outages and those whose homes or properties were damaged or destroyed. See below for more information.
