**ORDER NO. 06-01-22-02**

**EMERGENCY FIRE CLOSURE**

Pursuant to 16 USC § 551 and 36 CFR § 261.50 (a) and (b), the following acts are prohibited on National Forest System lands, roads and trails within the following described area on the Deschutes National Forest, and depicted in the attached Exhibit A. This Order becomes effective on September 5, 2022, and will remain in effect through November 30, 2022, or until rescinded.

**PROHIBITIONS:**

1. Going into or being within an area closed for public health and safety. [36 CFR § 261.53 (e)]
2. Being on the road. [36 CFR § 261.54 (e)]
3. Being on a trail. [36 CFR § 261.55(a)]

**Affected Area/Closure Area** is described as the area starting at the Lane CO/Deschutes CO/Klamath CO junction in T22S-R6E Sec 33 SESE. The fire closure boundary goes north following the Lane CO/Deschutes CO boundary to the Six Lakes Trail junction in T19S-R7E Sec 11 NESW. The boundary follows the Six Lakes Trail east to the Senoj Trail junction. The boundary then follows the Senoj Trail south to the north/south T19S-R7E line. The boundary then follows the T19S-R7E line south to the junction with the Three Sisters Wilderness boundary where sections 24, 25, 19 and 30 intersect between T19S-R7E and T19S-R8E. The boundary follows the Three Sisters Wilderness boundary south to FSR 4636 where it continues south following the Lemish Lake Trail and then Windigo Trail south to FSR 4290. The boundary follows FSR 4290 south east to the junction with the FSR 4290-200 road. The boundary follows FSR 4290-200 road to the junction with FSR 4292-400 where it continues along FSR 4292-481 to where the road becomes FSR 4650-345 then FSR 4650-340 where it ties into FSR 4650. The boundary follows FSR 4650 to FSR 4652. The boundary follows FSR 4652 to the junction with FSR 4662 then FSR 4664 until it joins with Deschutes CO/Klamath CO boundary lines in T22S-R7E Sec 33 SWSW. The boundary then follows the county line west to where it terminates with the boundary at the Lane CO/Deschutes CO/Klamath CO junction in T22S-R6E Sec 33 SESE.

This order closes all roads and trails within the closure boundary described above to include the Pacific Crest Trail (System Trail #2000) from Highway 58 north to the junction with the Six Lakes Trail near Elk Lake.

**EXEMPTIONS:**

Pursuant to 36 CFR § 261.50(e), the following persons are exempt from this order:

1. Persons with Forest Service Permit No. FS-7700-48 (permit for Use of Roads, Trails, or Areas Restricted by Regulation or Order), specifically exempting them from this order.
2. Any Federal, State, or local officer, or member of any organized rescue or fire fighting force in the performance of an official duty.

This prohibition is in addition to the general prohibitions in 36 CFR Part 261, Subpart A.

Violations of this prohibition are punishable by a fine of not more than \$5,000 for an individual or \$10,000 for an organization, or imprisonment for not more than 6 months, or both (16 USC § 551; 18 USC § 3551, 3559, 3571, and 3581)
