ORDER NO. 06-01-22-03

EMERGENCY FIRE CLOSURE

Pursuant to 16 USC § 551 and 36 CFR § 261.50 (a) and (b), the following acts are prohibited on National Forest System lands, roads and trails within the following described area on the Deschutes National Forest, and depicted in the attached Exhibit A. This Order becomes effective on September 9, 2022, and will remain in effect through November 30, 2022, or until rescinded.

This Order supersedes Order #06-01-22-02 signed by Forest Supervisor Holly Jewkes on September 4, 2022.

PROHIBITIONS:

- 1. Going into or being within an area closed for public health and safety. [36 CFR § 261.53 (e)]
- **2.** Being on the road. [36 CFR § 261.54 (e)]
- **3.** Being on a trail. [36 CFR § 261.55(a)]

Affected Area/Closure Area is described as the area starting at the Lane CO/Deschutes CO/Klamath CO junction in T22S-R6E Sec 33 SESE. The fire closure boundary goes north following the Lane CO/Deschutes CO boundary to the Wickiup Plains Trail in T18-R8E Sec 6. The boundary follows this trail east to FSR 46 (Cascade Lakes Highway). The boundary follows FSR 46 south to FSR 4625. The boundary follows FSR 4625 to the T19S-R8E Sec 8 east/west section line. The boundary follows the T19S-R8E section line east to the Metolius-Windigo Trail. The boundary turns south following the Metolius-Windigo Trail to the Edison-Lava Trail. The boundary turns east to the Edison Trail in T19S-R9E Sec 18 SESE. The boundary follows the Edison Trail south until it turns into FSR 4528. The boundary then follows FSR 4528 south to FSR 4525 road. The boundary follows FSR 4525 west to FSR 4278 where it continues to the south until it reaches FSR 4270. The boundary follows FSR 4270 south to FSR 42. The boundary follows FSR 42 to the west where it turns south on FSR 4280. The boundary follows the 4280 road until it turns east on FSR 4280-100 until it reaches the Wickiup Reservoir high water line. The boundary then follows the Wikiup Reservoir high water line south to FSR 46-794 in T22S-R8E Sec 7 SWSE where it follows this road to FSR 46. The boundary briefly follows FSR 46 east to FSR 4660. The boundary follows FSR 4660 south to the Deschutes CO/Klamath CO line in T22S-R7E Sec 34 SWSW. The boundary then follows the county line west to where it terminates with the boundary at the Lane CO/Deschutes CO/Klamath CO junction in T22S-R6E Sec 33 SESE.

This order closes all roads and trails within the closure boundary described above to include the Pacific Crest Trail (System Trail #2000) from Highway 58 north to the junction with the Wickiup Plains Trail near Devils Lake. This order also includes the Metolius-Windigo Trail (System Trail #99) at the Quinn Creek Trail Junction.

EXEMPTIONS:

Pursuant to 36 CFR § 261.50(e), the following persons are exempt from this order:

- 1. Persons with Forest Service Permit No. FS-7700-48 (permit for Use of Roads, Trails, or Areas Restricted by Regulation or Order), specifically exempting them from this order.
- 2. Any Federal, State, or local officer, or member of any organized rescue or fire fighting force in the performance of an official duty.

This prohibition is in addition to the general prohibitions in 36 CFR Part 261, Subpart A.

Violations of this prohibition are punishable by a fine of not more than \$5,000 for an individual or \$10,000 for an organization, or imprisonment for not more than 6 months, or both (16 USC § 551; 18 USC § 3551, 3559, 3571, and 3581)
