CURRENT SITUATION

<p>Situation Summary:</p>	<p>Lingering tropical moisture brought cloudy, cooler, and moist conditions to the fire on Saturday. A few showers were also reported, but little to no accumulation. Smoldering and creeping will continue. Moisture entering the area will inhibit rates of spread. Deep seated heat will still be present. Fuels will begin to dry out. ERC's will stabilize and begin slowly climbing. Smoldering and creeping activity will continue to increase. Deep-seated heat will continue to be found throughout the canyons and brush fields.</p>

South of Cactus Valley Road, East of Sage Road, North of Stanley Road to the Eastern Border of the Cahuilla Mountain Wilderness, North of the Southern border of the Cahuilla Mountain Wilderness Area, North of Tripps Flats, Northwest of Cottonwood Truck Trail, and West of Rouse Ridge to the burn area, East of Fairview Avenue, South of State Route 74 to the burn area.</p>

	Evacuation Warning: East of Soboba Street, West of Fairview Avenue, North of Stetson Avenue, and South of State Route 74, East of Fairview Avenue, West, and South of San Jacinto River, North of State Route 74, South of State Route 74 to Rouse Ridge and West of Rattlesnake Spring. South of Cactus Valley Road, North of East Benton Road, East of De Portola Road, and West of Sage Road. North of Wilson Valley Road and Reed Valley Road, South of Stanley Road, East of Sage Road, and West of the US Forest Service Boundary, including the road of Larkin Lane.
