FOREST ORDER No. 05-05-22-11

EMERGENCY FIRE CLOSURE – McKinney-Yeti Fires

Pursuant to 16 U.S.C. § 551 and 36 C.F.R. § 261.50(a) and (b), and to provide for public safety, the following acts are prohibited within the Happy Camp, Oak Knoll, and Scott River Ranger Districts of the Klamath National Forest. This Order is effective from September 2, 2022 through September 30, 2022.


1. Going into or being upon National Forest System lands within the McKinney Fire Restricted Area (described in Exhibit A) or the Yeti Fire Restricted Area (described in Exhibit B), as shown on the attached map, Exhibit C. **36 C.F.R. § 261.52(e).**
2. Being on any National Forest System Road within the McKinney Fire Restricted Area (listed in Exhibit A) or the Yeti Fire Restricted Area (listed in Exhibit B), as shown on the attached map, Exhibit C. **36 C.F.R. § 261.54(e).**
3. Being on any National Forest System Trail within the McKinney Fire Restricted Area (listed in Exhibit A) or the Yeti Fire Restricted Area (listed in Exhibit B), as shown on the attached map, Exhibit C. **36 C.F.R. § 261.55(a).**
4. Entering or using any Developed Recreation Site within the McKinney Fire Restricted Area (listed in Exhibit A) or the Yeti Fire Restricted Area (listed in Exhibit B), as shown on the attached map, Exhibit C. **36 C.F.R. § 261.58(b).**

Pursuant to 36 C.F.R. § 261.50(e), the following persons are exempt from this Order:

1. Persons with Forest Service Permit No. FS-7700-48 (Permit for Use of Roads, Trails, or Areas Restricted by Regulation or Order), specifically exempting them from this Order.
2. Any Federal, State, or local officer, or member of an organized rescue or fire-fighting force in the performance of an official duty.
3. Owners or lessees of land in the area to the extent necessary to access their property.

These prohibitions are in addition to the general prohibitions in 36 C.F.R. Part 261, Subpart A. A violation of these prohibitions is punishable by a fine of not more than \$5,000 for an individual or \$10,000 for an organization, or imprisonment for not more than 6 months, or both. 16 U.S.C. § 551 and 18 U.S.C. §§ 3559, 3571, and 3581.

EMERGENCY FIRE CLOSURE – McKinney Fire Restricted Area – Exhibit A

The boundary of the McKinney Fire Restricted Area begins at the intersection of the Klamath River with the western edge of Township 46 North, Range 10 West, Section 13 east of Brown Bear River Access, continuing northly along the eastern edge of Section 12 and Section 1 of Township 46 North, Range 10 West and Township 47 North, Range 10 West, Section 36 until it reaches the Latitude 41° 52' 30", continuing easterly along Latitude 41° 52' 30" until it reaches FSR 47N79 and continues northeasterly until it reaches the northern edge Township 47 North, Range 9 West, Section 32, continuing easterly until it reaches the eastern edge of Township 47 North, Range 9 West, Section 28 until it reaches the northern edge of Township 47 North, Range 9 West, Section 28 and continues easterly until it reaches FSR 40S01, continuing easterly through Township 47 North, Range 9 West, Section 27, continuing southerly along the western edge of Township 47 North, Range 9 West, Section 27, continuing easterly along the northern edge of Township 47 North, Range 9 West, Section 35 and Section 36, continuing northerly along FSR 47N41 through Township 47 North, Range 9 West, Section 25 and Township 47 North, Range 8 West, Section 30, continuing easterly along the northern edge and then southerly along the eastern edge of Township 47 North, Range 8 West, Section 30, continuing easterly along the northern and southerly along the eastern edge of Township 47 North, Range 8 West, Section 32, continuing along the easterly along the northern edge and southerly eastern edge of Township 46 North, Range 8 West, Section 4, continuing easterly along the northern edge of Township 47 North, Range 8 West, Section 10 and Section 11, continuing southerly along the eastern edge of Township 47 North, Range 8 West, Section 11, continuing easterly along the northern edge of Township 47 North, Range 8 West, Section 13 and Township 47 North, Range 7 West Section 18, continuing southerly along the eastern edge of Township 47 North, Range 7 West, Section 18, continuing easterly along the western edge of Siskiyou County 8J002 until the intersection with Siskiyou County 7H002 until the intersection with the eastern edge of Township 45 North, Range 8 West, Section 11, continuing southerly along the eastern edge through Township 45 North, Range 8 West, Section 11 and Section 15, continuing westerly along the southern edge and northerly along the western edge of Township 45 North, Range 8 West, Section 15, continuing easterly along the southern edge of Township 45 North, Range 8 West, Section 9 until the intersection with FSR 45N53, continuing along the northern edge of FSR 45N53 northerly, continuing north westerly along 45N28 until the western edge of Township 45 North, Range 8 West, Section 16, continuing along the southern edge of Township 45 North, Range 8 West, Section 8, continuing along FSR 49N49 through Township 45 North, Range 8 West, Section 8, Section 7, Section 18 and Township 45 North, Range 9 West, Section 13, continuing southerly along FSR 45N52 through Township 45 North, Range 9 West, Section 24, continuing westerly along the southern edge of Township 45 North, Range 9 West, Section 24 and Section 23, continuing north westerly along FSR 45N84X until the intersection with Latitude 122° 52' 30", continuing southerly along Latitude 122° 52' 30", continuing westerly along the southern edge of Township 45 North, Range 9 West, Section 20 and Section 21, continuing north

EMERGENCY FIRE CLOSURE – Yeti Fire Restricted Area – Exhibit B

The boundary of the Yeti Fire Restricted Area begins at the intersection of the southern bank of the Klamath River with eastern edge of Township 46 North, Range 12 West, Section 10; continuing southerly along the eastern edge of Section 15 until the summit of Grider Ridge Limestone Bluff on the eastern edge of Township 46 North, Range 12 West, Section 15, continuing southwesterly along Grider Ridge Limestone Bluffs until intersecting FSR 46N66 Grider Cr. Road Township 46 North, Range 12 West, Section 15, continuing southwesterly along 46N66 Grider Creek Road until its intersection with FSR 46N03 China Creek Road, FSR 46N95 China Peak Lower Road, and FSR 46N77 Grider Ridge Road in Township 46 North, Range 12 West, on the Section Line between Section 17 and Section 20, continuing southwesterly on FSR 46N03 China Creek Road/SIS 7C002 Township 46 North, Range 12 West, Section 20, Section 29, and Section 30, and Township 16 North, Range 8 East, Section 9, until the intersection with FSR 46N76 Joe Mills Road in Township 16 North, Range 8 East, Section 9, continuing northerly along FSR 46N76 Joe Mills Road until the section line between Township 16 North, Range 8 East, Section 4 and Section 5, continuing northerly along the western edge of Township 16 North, Range 8 East, Section 4 and Township 17 North, Range 8 East, Section 33, until the intersection with the Klamath River in Township 17 North, Range 8 East, Section 33, continuing easterly along the southern edge of the Klamath River until it reaches the starting point at the intersection of the southern bank of the Klamath River with eastern edge of Township 46 North, Range 12 West, Section 10.
