#### SHASTA-TRINITY NATIONAL FOREST FOREST ORDER NO. 14-23-07 DEEP FIRE CLOSURE ORDER

Pursuant to 16 U.S.C. § 551 and 36 C.F.R. § 261.50(a) and (b), and to provide for public safety, the following acts are prohibited within the Shasta-Trinity National Forest. This Order is effective from August 19, 2023, through December 31, 2023.

- Going into or being upon any National Forest System lands within the Deep Fire Closure Area, as described in Exhibit A and shown on Exhibit B. 36 C.F.R. § 261.52(e).
- 2. Being on any National Forest System Road within the Deep Fire Closure Area, as listed in Exhibit C and shown on Exhibit B. 36 C.F.R. § 261.54(e).
- 3. Being on any National Forest System trails within the Deep Fire Closure Area, as listed in Exhibit C and shown on Exhibit B. 36 C.F.R. § 261.55(a).

Pursuant to 36 C.F.R. § 261.50(e), the following persons are exempt from this Order:

- Persons with Forest Service Permit No. FS-7700-48 (Permit for Use of Roads, Trails, or Areas Restricted by Regulation or Order), specifically exempting them from this Order.
- 2. Any Federal, State, or local officer, or member of an organized rescue or fire fighting force in the performance of an official duty.

These prohibitions are in addition to the general prohibitions in 36 C.F.R. Part 261, Subpart A.

A violation of these prohibitions is punishable by a fine of not more than \$5,000 for an individual or \$10,000 for an organization, or imprisonment for not more than six months, or both. 16 U.S.C. § 551 and 18 U.S.C. §§ 3559, 3571, and 3581.

#### Exhibit A

The Boundary of the Deep Fire Closure begins at Caesar Peak, located at the intersection of the Shasta-Trinity National Forest Boundary and the Big Bar/Weaverville District Boundary and proceeds as follows:

- 1. The boundary then continues east along the Shasta-Trinity National Forest Boundary to its intersection with the Stuart Fork/Swift Creek-Trinity River Hydrologic Unit Code 10 (HUC10) Watershed boundary,
- then continues south along the ridge along the Stuart Fork/Swift Creek-Trinity River HUC10 Watershed boundary to its intersection with the east edge of Section 35, Township 36 N, Range 9 W, (MDM),
- 3. then continues south along section line to its intersection with the north edge of Section 3, Township 35 N, Range 9 W, (MDM),
- 4. then continues west along section line to its intersection with the east edge of Section 4, Township 35 N, Range 9 W, (MDM),
- 5. then continues south along section line to its intersection with the 09W21 trail,
- 6. then continues south along the 09W21 trail to its intersection with the north edge of Section 22, Township 35 N, Range 9 W, (MDM),
- 7. then continues west along section line to its intersection with the east edge of Section 21, Township 35 N, Range 9 W, (MDM),
- 8. then continues south along section line to its intersection with the north edge of Section 4, Township 34 N, Range 9 W, (MDM),
- 9. then continues west along section line to its intersection with the 10W10 trail,
- 10. then continues west along the 10W10 trail to its intersection with the north edge of Section 2, Township 34 N, Range 10 W, (MDM),
- 11. then continues west along the section line until its intersection with the Big Bar/Weaverville District Boundary,
- 12. then continues north along the Big Bar/Weaverville District Boundary until its intersection with the 10W06 trail,
- 13. then continues south along the 10W06 trail to its intersection with the 10W08 trail,
- 14. then continues north along the 10W08 trail to its intersection with the south edge of Section 16, Township 36 N, Range 10 W, (MDM),
- 15. then continues west along section line to its intersection with the east edge of Section 17, Township 36 N, Range 10 W, (MDM),
- 16. then continues north along section line to its intersection with the Big Bar/Weaverville District Boundary,
- 17. then continues north along the Big Bar/Weaverville District Boundary back to the starting point of the closure description boundary, as shown on the attached map (Exhibit B).
