

Fire

The Lookout Fire is 24,581 acres with 20% containment. The Bedrock Fire is 31,590 acres with 90% containment. Latest fire information is available at InciWeb: tinyurl.com/Fire-Information

Smoke

Temperatures are increasing and cloud cover are decreasing. We will likely continue to see GOOD air quality along Central Oregon. McKenzie is starting the day with USG and will likely remain that way for most of the day. Overnight air may go UNHEALTHY as the inversion sets in and smoke settles in the drainages. The air quality in Detroit Lake, Sweet Home, Eugene, and Cottage Grove should remain GOOD for today. Sisters will continue to see GOOD air quality for most of the day with brief periods of MODERATE as smoke from McKenzie pushes into the area.
