Fire


Fire activity remains low on these fire with continued interior smoldering, but no additional growth of significance is expected. Currently the Lookout fire is 25,751 acres with 50% containment and Pete's Lake is 3,254 acres and 50% containment. Latest fire information is available at InciWeb: tinyurl.com/Fire-Information

Smoke

Elevated smoke is expected in many areas in Central Oregon from smoke being transported in from fires in southwest Oregon and northwest California, with greater impacts to those communities east of the Cascades. This will be short lived as rain is forecasted in the next couple days both on those fires but across central Oregon later this weekend. Until that occurs, continued impacts are expected to continue in those communities along the McKenzie Highway near the Lookout Fire.
