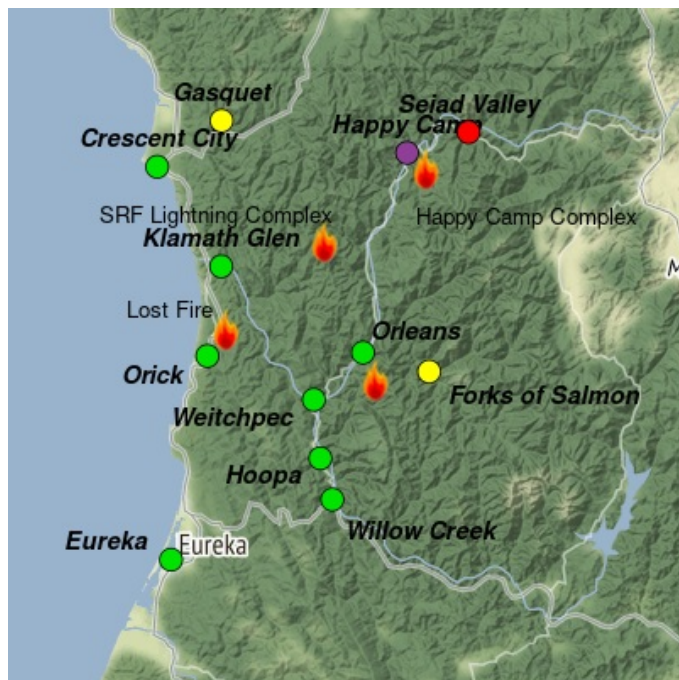

Fire

The Smith River Complex, Happy Camp Complex, and Six Rivers Forest Lightning Complex are showing some signs of increased activity as the warming and drying trend continues. Strategic firing operations are under consideration at all three fire complexes; test firing will occur as conditions allow. Smoke

Yesterday, increased fire activity particularly on the Perch, UFish, and Elliot fires put up smoke that has settled into surrounding drainages. That smoke will be slow to clear out today. Areas on the coast should enjoy GOOD air quality. Weitchpec, Hoopa, and Willow Creek should also enjoy GOOD conditions. Orleans should have overall GOOD air quality today with periods of USG possible. Forks of Salmon and Gasquet should have overall MODERATE air quality with potential periods of USG. Air Quality Index (AQI)	Actions to Protect Yourself
Good	None
Moderate	Unusually sensitive individuals should consider limiting prolonged or heavy exertion.
USG	People within Sensitive Groups* should reduce prolonged or heavy outdoor exertion.
Unhealthy	People within Sensitive Groups* should avoid all physical outdoor activity.
Very Unhealthy	Everyone should avoid prolonged or heavy exertion.
Hazardous	Everyone should avoid any outdoor activity.
