Air quality advisory for Curry and Josephine counties through Sunday night.

Fire


Increasing area fire activity will continue to bring thick smoke impacts to the forecast area. Coastal communities will see periods of relief this afternoon. Dropping humidity and increasing temps will support increasing fire activity in previously unburned areas inside the Smith River Complex fire perimeters.

Smoke

Thick smoke in the Illinois Valley will remain V.UNHEALTHY to HAZARDOUS for most of the day. Light clearing conditions between 2-4pm can be expected along with high level hazy conditions. Marine fog and offshore smoke will limit visibility in Brookings until mid-morning when conditions improve into the afternoon. Locations SW of Grants Pass and Medford will continue to deal with V.UNHEALTHY smoke conditions until late afternoon with winds start pushing smoke impacts toward the Klamath river drainage.

HWY 199 RESTRICTIONS

If you're traveling around the SW Oregon and Northern California area, check the fire specific smoke forecasts on the fire and smoke map before you go. Link provided below. HWY 199 has controlled access with one-way pilot cars assigned. Expect 3hr delays and periods of very restricted access. Avoid this area if possible.
