# **Quarry Fire Update**

### **Fire Statistics:**

**Location:** The Quarry Fire is located on the Stanislaus National Forest, Mi-Wok Ranger District, off Forest Road 3N01, east of Bourland Creek and near the Emigrant Wilderness west of Cherry Creek.

**Acres Burned to Date:** 5,557 **Containment:** 13.5% **Total Personnel:** 119

Cause: Lightning Injuries: 0

**Background:** The Quarry fire was one of many fires ignited by lightning strikes across the forest on September 9, 2023. District fire managers immediately worked to ensure these naturally ignited fires stayed within pre-determined boundaries. Fire personnel with the Stanislaus National Forest are currently managing the Quarry Fire to achieve multiple resource objectives.

<u>Current Activities:</u> No fire movement today due to recent moisture. Crews made improvements to holding lines, including using natural features such as granite outcroppings to improve effectiveness.

Fire professionals are managing fire behavior and intensity to provide for multiple resource benefits including reducing concentrations of all fuels, re-establishing multigenerational timber stands, improving wildlife habitat, promoting plant diversity, and re-introducing fire into fire adapted ecosystems.

<u>Closures:</u> Soft closures are in effect to provide for the safety of the public utilizing public lands as well as fire personnel working in the area. The soft closures are an encouragement for the public to stay clear of the area, to find alternate routes to their locations and to provide fire personnel the widest berth possible as they go about their mission.

With the public's cooperation, we will continue to monitor the number and duration of soft closures, recognizing that fire personnel and public safety is the focus.

**Smoke:** Smoke impacts from the Quarry Fire, the prescribed burns of the Experimental Forest, Dry Meadows and Beardsley Burn units on the Summit Ranger District will cause smoke to settle in low lying areas.
