**Adams Fire Emergency Area Closure
For Public Health and Safety**

PROHIBITIONS

Pursuant to 16 U.S.C. § 551 and 36 C.F.R. § 261.50(a) and (b), the following are prohibited on the National Forest System (NFS) lands, roads, and trails in the Mesa Ranger District, Tonto National Forest, described below and shown on the attached map incorporated into this Order as Exhibit A (the "Described Area and Trails"):

1. Going into or being upon the Described Area. 36 C.F.R. § 261.53(e).
2. Being upon the Described Trail. 36 C.F.R. § 261.55(a).

EXEMPTIONS

Pursuant to 36 C.F.R. § 261.50(e), the following persons are exempt from this Order:

1. Persons with Forest Service Permit No. FS-7700-48 (Permit for Use of Roads, Trails, or Areas Restricted by Regulation or Order), specifically exempting them from this Order or a written determination by a Forest Service authorized officer that a permit is not required under 36 C.F.R. § 251.50(e)(1) or (2).
2. Any Federal, State, or Local Officer, or member of an organized rescue or firefighting resource in the performance of an official duty.

DESCRIBED AREA AND TRAILS

All National Forest System (NFS) lands, roads, and trails within the boundary beginning at the intersection of State Route (SR) 87 and NFS Road 204 (commonly referred to as

Bush Highway), following southwest along the north side of SR 87 until the junction with the Non-Forest Service Ownership, then following along the Non-Forest Service Ownership north then west to the Fort McDowell/Yavapai Nation Reservation boundary, then following along the east side of the Fort McDowell/Yavapai Nation Reservation boundary north around the Non-Forest Service Ownership then continuing north along the east side of the Fort McDowell/Yavapai Nation Reservation boundary to Global Positioning System (GPS) or "Point Coordinates" 33° 42.557' N / -111° 37.249' W, then following directly east two miles until the junction of Motorized Trail (MT) 1096 at "Point Coordinates" 33° 42.568' N / -111° 35.048' W, then following northeast and northwest along MT-1096 until its intersection with MT-160, then following northeast along MT-160 until its intersection with MT-P5008, then following along MT-P5008 northeast until its intersection with MT-P5007B, then following along MT-P5007B northeast until its intersection with MT-P5004A, then following north along MT-P5004A until its intersection with MT-3456, then following east along MT-3456 to its intersection with SR 87, then following along the west and north side of SR 87 southwest, back to the point of beginning, at the intersection of SR 87 and Bush Highway.

Note: Motorized Trails 1096, 160, P5008, P5007B, P5004A, and 3456 comprising the Described Area boundary are closed.

SR-87 remains open.

PURPOSE

To provide public health and safety due to firefighting operations and fire danger associated with the uncontrolled Adams Fire on the Tonto National Forest.

IMPLEMENTATION

1. This Order shall be in effect from Monday, June 03, 2024, at 1:00pm through July 15, 2024, at 6:00pm, unless rescinded.
2. A map identifying the Described Area and Trails is attached and made part of this Order as Exhibit A. For a digital version of this Order and Exhibit A, go to <https://www.fs.usda.gov/alerts/tonto/alerts-notice>
3. Unless otherwise expressly defined in this Order, the terms used in this Order are defined by the regulations of the Secretary of Agriculture, 36 C.F.R. Chapter II, Parts 200-299. If there are terms in this Order that are not expressly defined in the Order or 36 C.F.R. Chapter II, Parts 200-299, their meaning shall be determined by their plain language definitions.
4. A violation of the above prohibitions is punishable as a Class B misdemeanor by a fine of not more than \$5,000 for individuals and \$10,000 for organizations, or by imprisonment for not more than six months, or both. 16 U.S.C. § 551; 18 U.S.C. §§ 3559, 3571, and 3581.

6. This Order supersedes any previous Orders prohibiting the same or similar acts in the same Described Area and Trails.
