
A mobile smoke monitor was deployed in Manson yesterday and added to the Outlook.

Fire

The Pioneer Fire remains active and continues to burn along steep, rugged slopes. Tactical suppression efforts are focused on structure protection, establishing control features, and reinforcing lines. Aerial fire suppression and cloud cover moderated fire spread yesterday, and similar fire behavior is expected today. A warming trend caused by a ridge of high pressure is expected to begin tomorrow. Fire activity is expected to increase moderately to include uphill runs, isolated torching, spotting, and smoldering. Fire progression into drainages with thicker vegetation will likely result in an increase in smoke production.

Smoke

Yesterday, terrain aligned NW winds transported smoke to the SE, but moderated smoke production kept areas of the Outlook in the GOOD air quality category. Today, smoke will again track mostly to the SE; however, winds will begin to be more terrain influenced, moving upslope/up valley during the day and down drainage at night. Under these conditions we'll likely see more smoke settling in Lake Chelan and the lower Methow Valley. MODERATE conditions are possible in Chelan, Manson, and Methow by the late afternoon with improvement overnight. Stehekin, Winthrop, and Twisp should see generally GOOD air quality with most smoke staying to the south of those locations.
