PROHIBITIONS

Pursuant to 16 U.S.C. § 551 and 36 C.F.R. § 261.50 (a) and (b), the following acts are prohibited on the National Forest System (NFS) lands, roads, and trails within the Boise National Forest described below and shown on the attached map incorporated into this Order as Exhibit A (the "Described Area, Roads, and Trails").

- 1. Going into or being upon the Described Area. 36 CFR § 261.52(e).
- 2. Being on the Described Roads. 36 CFR § 261.54(e).
- 3. Being on the Described Trails. 36 CFR § 261.55(a).

EXEMPTIONS

Pursuant to 36 C.F.R. § 261.50(e), the following persons are exempt from this Order:

- 1. Persons with Forest Service Permit No. FS-7700-48 (Permit for Use of Roads, Trails, or Areas Restricted by Regulation or Order), specifically exempting them from this Order or a written determination by a Forest Service authorized officer that a permit is not required under 36 C.F.R. § 251.50(e)(1) or (2).
- 2. Any Federal, State, or local officer, or member of an organized rescue or fire fighting force in the performance of an official duty.
- 3. Federal or State administrative personnel in the performance of an official duty.

DESCRIBED AREA/ROADS/TRAILS

The Described Area is all NFS lands within the following boundaries: Beginning where NFS Road #446 enters the East boundary of Section 2, Township 12 North, Range 3 East; continuing South to the SE corner of Section 14, Township 12 North 3 East; Continuing West to the Cascade Ranger District Boundary in the South Boundary of Section 17, Township 12 North, Range 3 East; Continuing North along the Cascade

Ranger District Boundary in Sections 17, 8, 5, and 6 in Township 12 North, Range 3, and Sections 31, 30, 19, 20, and 17 in Township 13 North, Range 3 East to the North Boundary of Section 17, Township 13 North, Range 3 East; Continuing East to the NE corner of Section 15, Township 13 North, Range 3 East; Continuing South to the SE corner of Section 15, Township 13 North, Range 3 East; Continuing East to the NE Corner of Section 23, Township 13 North, Range 3 East; Continuing South to where NFS Road #446 crosses the East boundary of Section 2, Township 12 North, Range 3 East.

The Described Area is located within the Boise National Forest, Cascade Ranger District.

The Described Roads are all NFS Roads located within the Described Area: NFS Roads #404, #404A, #404B, #404B1, #404B3, #404C, #404D, #404D1, #404F, #404G, #404G2, #421, #421A, #421B, #421C, #421C2, #421C3, #421D, #421E, #421E1, #421F, #421G, #446, #446A, #446A3, #446B, #446C, #446C1, #446C2, #446D, #446E, #446F, #446G, #446H, #645, #645X, #645Z, and #645Z1.

The Described Trails are all NFS Trails located within the Described Area: NFS Trails #119, #125, and #204.

PURPOSE

The purpose of this Order is to protect public safety during the Boulder Creek Fire.

IMPLEMENTATION

- 1. This Order shall be in effect from July 30, 2024, at 07:00 AM and shall remain in effect until December 31, 2024, at 11:59 PM, unless rescinded.
- 2. A map identifying the Described [Area/Roads/Trails] is attached and made part of this Order as Exhibit A. For a digital version of this Order and Exhibit A, go to https://www.fs.usda.gov/alerts/Boise/alerts-notices.
- 3. Unless otherwise expressly defined in this Order, the terms used in this Order are defined by the regulations of the Secretary of Agriculture, 36 C.F.R. Chapter II, Parts 200-299. If there are terms in this Order that are not expressly defined in the Order or 36 C.F.R. Chapter II, Parts 200-299, their meaning shall be determined by their plain language definitions.
- 4. A violation of the above prohibitions is punishable as a Class B misdemeanor by a fine of not more than \$5,000 for individuals and \$10,000 for organizations, or by imprisonment for not more than six months, or both. 16 U.S.C. § 551; 18 U.S.C. §§ 3559, 3571, and 3581.
