# 7/10 - 7/11

Issued by Wildland Fire Air Quality Response Program on July 10, 2024 at 06:05 AM PDT

## Special Statement

The National Weather Service has issued a Red Flag Warning for Wind and Low Relative Humidity and an Excessive Heat Warning through Wednesday. \*\*\* Washington State Dept of Ecology has issued an Air Quality Advisory for all of Chelan County plus the Methow Valley down to Brewster in Okanogan County until further notice, due to expected smoke from the Pioneer fire and other regional wildfires.\*\*\*

## Fire


The Pioneer Fire last reported 11,329 acres burned with 14% containment. Continued hot, dry, and breezy conditions will contribute to a critical fire day. Fire behavior will include areas of fingering head runs, flanking, and backing. Expect very active fire conditions to persist into the weekend.

# Smoke

Hot and dry weather continues to support vigorous smoke production. Westerly winds will steer smoke towards the lower Methow Valley. Stehekin and Winthrop will tend towards GOOD air quality with some MODERATE. Manson and Chelan should see mostly MODERATE with occasional USG. The lower Methow Valley may experience USG and perhaps some UNHEALTHY as the smoke tracks east.
