FOREST ORDER PYRAMID FIRE EMERGENCY AREA CLOSURE

Pursuant to 16 U.S.C. § 551 and 36 CFR § 261.50 (a) and (b), and to provide for public safety, the following acts are prohibited on the National Forest System ("NFS") areas, roads, and trails described below within the administrative boundaries of the Willamette National Forest. Refer to exhibit A for the map and exhibit B for trails and recreation sites that are closed. This Order supersedes Order # 06-18-03-30 and is effective on August 28, 2024, through November 15, 2024, unless otherwise rescinded sooner.

PROHIBITIONS:

- 1. Being on the road. 36 CFR § 261.54(e)
- 2. Being on a trail. 36 CFR § 261.55(a)
- 3. Entering into or being upon National Forest System Lands closed for the protection of public health and safety. **36 CFR § 261.53(e)**

CLOSURE AREA:

The closure area is located within the State of Oregon, Linn County, and within the Administrative Boundaries of the Willamette National Forest. The closure applies to the NFS areas, roads, Middle Santiam Wilderness, trails, and trailheads described below. The closure area is depicted on the attached map, which is incorporated into this order as "Exhibit A". All areas, roads, trails, campgrounds, and recreation sites within this closure area are closed. However, all roads and trails that serve as the boundary of this closure area remain open. Recreation sites, trails and campgrounds closed by this order are depicted in "Exhibit B."

Area Closure Description

The closure boundary starts at the junction of Forest Service (FS) Roads 1100 and 1142 and proceeds east along FS Road 1100 until the intersection with FS Road 1161. The closure then follows FS Road 1161 south. Just north of Scar Mountain, the boundary aligns with the west edge of section 4 of Township 12 South (T12S) and Range 6 East (R6E), where it continues south until it reaches FS Road 2266-450. The closure boundary then follows FS Road 2266-450. southeast until it reaches FS Road 2266. The closure boundary follows FS Road 2266 south to the North Pyramid trailhead where it then heads south following the North Pyramid Trail (FS Trail 4161), the Pyramids Trail (FS Trail 3380), and the South Pyramid Creek Trail (FS Trail 3403) until it reaches the Cresent Mountain Trail (FS Trail 3384). The closure boundary follows Cresent Mountain Trail south to the southern edge of section 4 of T13S and R6E. It follows the edge of section 4 and 5 west to FS Road 2049-642. The closure boundary follows FS Road 2049-642 south to FS Road 2049-635 and continues along this road to FS Road 2049. The closure boundary then follows FS Road 2049 west and south until it reaches the junction of FS Roads 2047, 2045, and 2043. The closure boundary continues west along FS Road 2043 until it reaches FS Road 2043-320. It continues north along FS Road 2043-320 to the intersection of Cool Camp at FS Roads 2041 and 2027. The closure continues west in sections 32 and 31 of

T12S and R5E, then it follows the Willamette National Forest boundary north along sections 31, 30, 19, 18, and 7 of T12S and R5E. The closure continues following the Willamette National Forest boundary west in section 1 of T11S and R4E to FS Road 1142. The closure boundary then follows FS Road 1142 north to FS Road 1100.

EXEMPTIONS:

Pursuant to 36 CFR § 261.50(e)(1) and (4), the following persons are exempt from this Order:

- (1) Persons with Forest Service Permit No. FS-7700-48 (Permit for Use of Roads, Trails, or Areas Restricted by Regulation or Order) specifically exempting them for this Order.
- (2) Any Federal, State, or Local Officer, or member of organized rescue or fire fighting force in the performance of an official duty.

These prohibitions are in addition to the general prohibitions in 36 CFR Part 261, Subpart A.

Violations of these prohibitions are punishable by a fine of not more than \$5,000.00 for an individual or \$10,000.00 for a corporation or imprisonment for not more than six months or both. 16 U.S.C. § 551 and 18 U.S.C. § 3551, 3571, and 3581.
