

Six Rivers National Forest
Forest Order No. 10-24-09
Hill Fire Closure

Pursuant to 16 U.S.C. § 551 and 36 C.F.R. § 261.50(a) and (b), and to provide for public safety, the following acts are prohibited within the Lower Trinity Ranger District of the Six Rivers National Forest. This Order is effective from August 6, 2024, through September 15, 2024.

1. Going into or being upon National Forest System lands within the Hill Fire Closure Area, as described in Exhibit A and shown on Exhibit B. 36 C.F.R. § 261.52(e).
2. Being on any National Forest System road within the Hill Fire Closure Area, as shown on Exhibit B. 36 C.F.R. § 261.54(e).
3. Being on any National Forest System trail within the Hill Fire Closure Area, as shown on Exhibit B. 36 C.F.R. § 261.55(a).

Pursuant to 36 C.F.R. § 261.50(e), the following persons are exempt from this Order:

1. Persons with Forest Service Permit No. FS-7700-48 (Permit for Use of Roads, Trails, or Areas Restricted by Regulation or Order), specifically exempting them from this Order.
2. Any Federal, State, or local officer, or member of an organized rescue or fire-fighting force in the performance of an official duty.
3. Owners, lessees, or residents of private landholdings in the area, to the extent necessary to access their land.

These prohibitions are in addition to the general prohibitions contained in 36 C.F.R. Part 261, Subpart A.

A violation of these prohibitions is punishable by a fine of not more than \$5,000 for an individual or \$10,000 for an organization, or imprisonment for not more than six months, or both. 16 U.S.C. § 551 and 18 U.S.C. §§ 3559, 3571, and 3581.

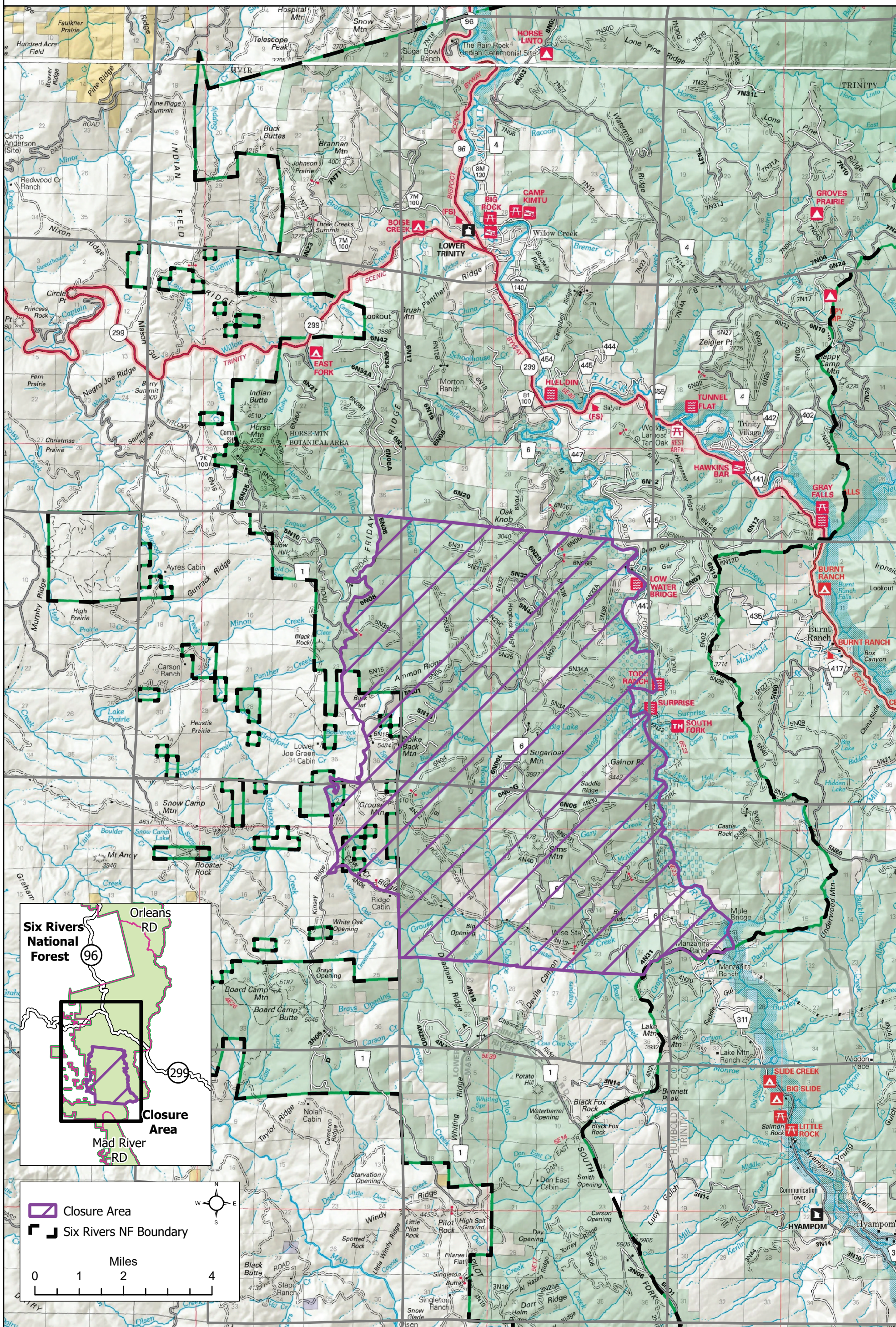

Exhibit A

The Hill Fire Closure Area comprises a portion the southwestern quarter of the Lower Trinity Ranger District of the Six Rivers National Forest as shown on Exhibit B. The closure area begins where the South Fork Trinity River intersects Township 5 North, Range 5 East, Section 1, the closure continues south along the South Fork Trinity River to the Shasta Trinity National Forest boundary. The closure continues west along the Shasta Trinity National Forest boundary until it intersects with Township 4 North, Range 5 East, Section 25. The closure continues west along the northern section line of Township 4 North, Range 5 East, Sections 25-30 until it intersects the western boundary of the Six Rivers National Forest. The closure area then continues north along the Six Rivers National Forest boundary until it intersects with Forest Road 4N06 (Cow Creek Road). The closure area follows Forest Road 4N06 (Cow Creek Road) northwest until it intersects with Forest Route 1. The closure area continues north on Forest Route 1 until it intersects with Forest Road 6N08 (Friday Ridge Road). The closure then continues northeast along the south side of Forest Road 6N08 (Friday Ridge Road) until it intersects with Township 5 North, Range 4 East, Section 36. The closure continues east following the southern section line of Township 5 North, Range 4 East, Section 36 and Township 5 North, Range 5 East, Sections 31-35 until the starting point at the South Fork Trinity River.
