

**SIX RIVERS NATIONAL FOREST

BOISE FIRE CLOSURE ORDER**

Pursuant to 16 U.S.C. § 551 and 36 C.F.R. § 261.50(a) and (b), and to provide for public safety, the following acts are prohibited within Six Rivers National Forest and Klamath National Forest. This Order is effective from August 16, 2024, through September 15, 2024.

1. Going into or being upon National Forest System lands within the Boise Fire Closure Area, as described in Exhibit A and shown on Exhibit B. 36 C.F.R. § 261.52(e).
2. Being on any National Forest System Road within the Boise Fire Closure Area, as shown on Exhibit B. 36 C.F.R. § 261.54(e).
3. Being on any National Forest System trail within the Boise Fire Closure Area, as shown on Exhibit B. 36 C.F.R. § 261.55(a).
4. Entering or using Le Perron Flat Dispersed Camping Area, Salmon Summit Trail Head, Big Rock River Access, Nordheimer Campground and High Point Trailhead. 36 C.F.R. § 261.58(b).

Pursuant to 36 C.F.R. § 261.50(e), the following persons are exempt from this Order:

1. Persons with Forest Service Permit No. FS-7700-48 (Permit for Use of Roads, Trails, or Areas Restricted by Regulation or Order), specifically exempting them from this Order.
2. Any Federal, State, or local officer, or member of an organized rescue or fire-fighting force in the performance of an official duty.
3. Owners, lessees, or residents of private landholdings in the area, to the extent necessary to access their land.

These prohibitions are in addition to the general prohibitions contained in 36 C.F.R. Part 261, Subpart A.

A violation of these prohibitions is punishable by a fine of not more than \$5,000 for an individual or \$10,000 for an organization, or imprisonment for not more than six months, or both. 16 U.S.C. § 551 and 18 U.S.C. §§ 3559, 3571, and 3581.

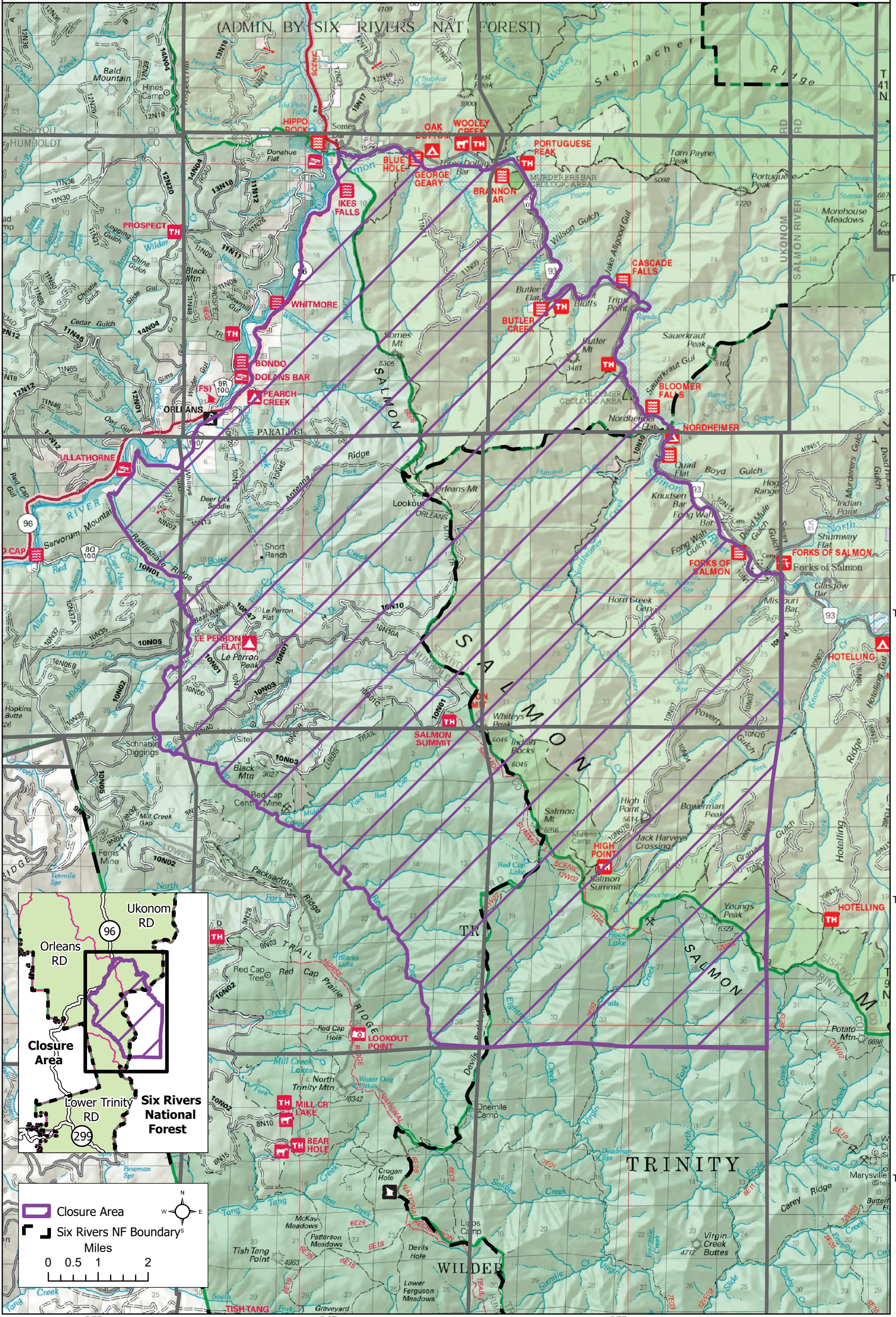

**Exhibit A**

The Boise Fire Closure Area comprises a portion the southern quarter of the Orleans Ranger District of the Six Rivers National Forest and the northern quarter of the Salmon/Scott Ranger District of the Klamath National Forest as shown on Exhibit B. The closure area begins where Highway 96 and the Salmon River intersect at the Humboldt/Siskiyou County line, the closure continues southwest along Highway 96 until it intersects County Road 8Q 100 (Red Cap Road). The closure then continues southwest along County Road 8Q 100 (Red Cap Road) which becomes Forest Road 10N01 and turns southeast. The closure then continues southeast on Forest Road 10N01 until it intersects Forest Road 10N02, where it then continues along Forest Road 10N02 until it intersects Red Cap Creek. The closure then continues southeast along Red Cap Creek until it intersects with Township 9 North, Range 6 E, Section 36. The closure then continues east following the southern section line of Township 9 North, Range 6 E, Section 36 and east along Township 9 North, Range 7 E, Sections 31 through 36 until it intersects Township 9 North, Range 7 E, Section 36. The closure then continues north following the eastern edge of Township 9 North, Range 7 E, Section 36, 25, 24, 13, 12 and 1. The closure continues following the eastern edge of Township 10 North, Range 7E, Sections 36, 25, 24 and 13 as it continues north until it intersects the Salmon River. The closure area continues northwest along the Salmon River until it intersects the starting point at Highway 96.
