Shift in weather expected, mop up focus of firefighting activity

COTTAGE GROVE, Ore. – The northern portion of the Cottage Grove – Lane 1 Fire is in patrol status, while all other areas are now in mop up. This transition to mop up will further secure the perimeter, resulting in increases to the fire's containment. Today, the containment has increased to 42%.

Mop up is the methodical process firefighters use to work in from the perimeter of the fire, locating areas of heat that could rekindle, using tools such as a shovel or a Pulaski and water they can extinguish these hot spots. Areas are gone over multiple times to ensure there is no residual fire. After mopping up, the area is patrolled regularly by firefighters, looking for visible smoke.

With the northern area of the fire in patrol status, the Level 1 evacuation notice for the community of Disston and homes along Brice Creek Road was cancelled by the Lane County Sheriff's Office. The Level 3 evacuation notice remains in place for the Bohemia Mining District and Fairview Peak.

Tree fallers continue to work removing hazard trees adjacent to the fireline and near roads. Clearing roads has been prioritized to allow for one way travel routes and improve safety for firefighters, as well as limit hazards in the future when the area opens to the public once again.

Firefighters are expecting a shift in the weather today, including the potential for rain, hail, wind and thunderstorms. Firefighter safety will be prioritized as these conditions are monitored throughout the day.

Lane County Waste Management's Sharp's Creek Road transfer site will be closed Saturday, August 17th due to activity in the area related to firefighting resources for Cottage Grove – Lane 1 Fire. The closure will be re-evaluated early next week. The Cottage Grove site is open on its regular schedule.

Closures: Due to the wildfires, the Umpqua National Forest has issued two closures impacting every district of the forest. Cottage Grove

Evacuations: A "Level 3" evacuation notice is in effect for the Bohemia Mining District and Fairview Peak. An evacuation map is available at: <u>www.LaneCountyOR.gov/Lane1Fire</u>.

Temporary Flight Restriction (TFR): A "TFR" is in place at an altitude from the surface up to and including 8500 feet, daily (24 hours) until further notice. Flying a drone near or around a wildfire compromises the safety of pilots and interferes with firefighting efforts.
