# Fire


Currently at 11,946 acres, the Boise Fire grew 215 ac. yesterday and is 13 percent contained. Following a quiet day on Sunday, a marked drying/warming trend the next couple of days will promote increased smoke production from interior smoldering as well as operational efforts to further secure/deepen control lines. Growing confidence in a significant fire-slowing pattern for late in the week.

## Smoke

Light to moderate smoke should increase during the next two days. **MODERATE air quality, overall, may occasionally become UNHEALTHY for SENSITIVE GROUPS (USG)** for areas immediately east-northeast of the fire to include the Salmon River Rd., Forks of Salmon, Cecilville and Etna. Even with an increase in smoke production, very favorable dispersion can be expected through Tuesday. Morning inversions will remain weaker than normal for late August. Light smoke should also become more visible along the Highway 96 corridor from Orleans to the Hoopa Valley.
