FOREST ORDER NO. 05-12-53-24-02  
Line FIRE CLOSURE ORDER**

Pursuant to 16 U.S.C. § 551 and 36 C.F.R. § 261.50(a) and (b), and to provide for public safety, the following acts are prohibited within the San Bernardino National Forest. This Order is effective from September 8, 2024 at 6:00PM PST through November 30, 2024.

1. Going into or being upon any National Forest System lands within the Line Fire Closure Area, as described in Exhibit B and shown on Exhibit A. 36 C.F.R. § 261.52(e).
2. Being on any National Forest System Road within the Line Fire Closure Area, as listed in Exhibit C and shown on Exhibit A. 36 C.F.R. § 261.54(e).
3. Being on any National Forest System Trail within the Line Fire Closure Area, as listed in Exhibit C and shown on Exhibit A. 36 C.F.R. § 261.55(a).

Pursuant to 36 C.F.R. § 261.50(e), the following persons are exempt from this Order:

1. Persons with Forest Service Permit No. FS-7700-48 (Permit for Use of Roads, Trails, or Areas Restricted by Regulation or Order), specifically exempting them from this Order.
2. Any Federal, State, or local officer, or member of an organized rescue or fire fighting force in the performance of an official duty.
3. Owners or lessees of land, to the extent necessary to access their land.

These prohibitions are in addition to the general prohibitions in 36 C.F.R. Part 261, Subpart A.

A violation of these prohibitions is punishable by a fine of not more than \$5,000 for an individual or \$10,000 for an organization, or imprisonment for not more than six months, or both. 16 U.S.C. § 551 and 18 U.S.C. §§ 3559, 3571, and 3581.

**Exhibit B**

The Line Fire Closure boundary begins at the intersection of State Highway 18 and the southwestern edge of Section 14 of Township 1 North, Range 4 West, San Bernadino Base and Meridian (SBBM); then continues northeast along the eastern southern edge of State Highway 18 to its intersection with the Northeastern edge of Section 36 of Township 2 North, Range 3 West, SBBM; then south to the Southeast corner of Section 1 Township 1 North, range 3 West, SBBM; then east along the section line and south along the district boundary while moving south to the Southeast corner of Section 21 Township 1 North, Range 1 West, SBBM; to the intersection of State Highway 38, following the western edge of State Highway 38 to the intersection of southeastern corner of section 12 Township 1 South, Range 2 West, SBBM; Follow west along the forest boundary line to Southwest corner of section 9 Township 1 South, Range 2 West, SBBM; then heading north to the Northwest corner of section 9 Township 1 South, Range 2 West, SBBM; then heading West along the section lines and forest boundary to section 6 Township 1 South, Range 2 West, SBBM; following the forest boundary North to the Southwest corner of section 30 Township 1 North, Range 3 West, SBBM; Intersecting with the forest boundary follow West to section 26 Township 1 North, Range 2 West, SBBM; then following the forest boundary west to the Northwest corner of section 14 Township 1 North, Range 3 West, SBBM; continues back to the starting point as shown on Exhibit B.
