LINE FIRE CLOSURE ORDER**

Pursuant to 16 U.S.C. § 551 and 36 C.F.R. § 261.50(a) and (b), and to provide for public safety, the following acts are prohibited within the San Bernardino National Forest. This Order is effective from September 9, 2024, at 10:00 PM PST, through November 30, 2024.

1. Going into or being upon any National Forest System lands within the Line Fire Closure Area, as described in Exhibit B and shown on Exhibit A. 36 C.F.R. § 261.52(e).
2. Being on any National Forest System Road within the Line Fire Closure Area, as listed in Exhibit C and shown on Exhibit A. 36 C.F.R. § 261.54(e).
3. Being on any National Forest System Trail within the Line Fire Closure Area, as listed in Exhibit C and shown on Exhibit A. 36 C.F.R. § 261.55(a).

Pursuant to 36 C.F.R. § 261.50(e), the following persons are exempt from this Order:

1. Persons with Forest Service Permit No. FS-7700-48 (Permit for Use of Roads, Trails, or Areas Restricted by Regulation or Order), specifically exempting them from this Order.
2. Any Federal, State, or local officer, or member of an organized rescue or fire fighting force in the performance of an official duty.
3. Owners or lessees of land, to the extent necessary to access their land.

These prohibitions are in addition to the general prohibitions in 36 C.F.R. Part 261, Subpart A.

A violation of these prohibitions is punishable by a fine of not more than \$5,000 for an individual or \$10,000 for an organization, or imprisonment for not more than six months, or both. 16 U.S.C. § 551 and 18 U.S.C. §§ 3559, 3571, and 3581.

All National Forest System Lands within the described boundary beginning at a point of intersection of the east edge of Interstate 15 and Forest Service Road 2N47 and continuing along the southern edge of 2N47 to State Highway 138, then continuing along the easter edge of State Highway 138 to a point of intersection with the northern line of Section 31, Township 3N., Range 4W., then continuing easterly along the forest boundary to the intersection of forest road 4N16, then southerly along the western edge of forest road 4N16 to the intersection of forest road 3N14, then south-easterly along the southern edge of forest road 3N14 to a point of intersection with the eastern line of Section 3, T. 2N., R. 1W., then south along the eastern line of Section 3, T. 2N., R. 1W., and 10 to the SW corner of the SW1/4NW1/4 of Section 11, T. 2N., R., 1W., then easterly and southerly along the forest boundary to the NE corner of the SE1/4SE1/4 of Section 15, T. 2N., R., 1W., then to a point of intersection with State Highway 38, then south-easterly along the eastern edge of State Highway 38 to the intersection of State Highway 18, then south-easterly along the southern edge of State Highway 18 to a point of intersection with the northern line of Section 26, T. 2N., R. 1W., then easterly along the forest boundary to the point of intersection with State Highway 38, then south-easterly along the western edge of State Highway 38 to the point of intersection with Section 12, T. 1N., R. 2E., then continuing easterly along the northern edge of Sections 7 and 8, T. 1N., R. 3E., to the NE corner of Section 8, T. 1N., R. 3E., then continuing south along the eastern line of Sections 8, 17, and 20, T. 1N., R. 3E., to the SW corner of Section 20, T., 1N., R. 3E., then continuing southerly, easterly, and northwesterly along the forest boundary to a point of intersection with the eastern edge of Interstate 15, then continuing northerly along the eastern edge of Interstate 15 back to the point of origin.
