**Logan Fire Road and Trail Closure**

**PROHIBITIONS**

Pursuant to 16 U.S.C. § 551 and 36 C.F.R. § 261.50(b), the following are prohibited on the National Forest System (NFS) roads and trail on the Payette National Forest, Krassel Ranger District, described below and shown on the attached map incorporated into this Order as Exhibit A (the "Described Roads and Trail"):

1. Being on the Described Roads. 36 C.F.R. §§ 261.54(e).
2. Being on the Described Trail. 36 CFR § 261.55(a).

**EXEMPTIONS**

Pursuant to 36 C.F.R. § 261.50(e), the following persons are exempt from this Order:

1. Persons with Forest Service Permit No. FS-7700-48 (Permit for Use of Roads, Trails, or Areas Restricted by Regulation or Order), specifically exempting them from this Order or a written determination by a Forest Service authorized officer that a permit is not required under 36 C.F.R. § 251.50(e) (1) or (2).
2. Any Federal, State, or local officer, or member of an organized rescue or fire fighting force in the performance of an official duty.
3. Federal or State administrative personnel in the performance of an official duty.

**DESCRIBED ROADS AND TRAIL**

The Described Roads are: (1) NFS Road #371 (Big Creek-Smith Creek Road), from the North End of the Big Creek Airstrip at the junction with the Storage Shed access road North to its junction with NFS Road #373; and (2) NFS Road #373 (Pueblo Summit Road) in its entirety. The Described Roads are located in Sections 4 and 26, Township 21 North, Range 9 East, P.M.

The Described Trail is NFS Trail #194 (Smith Creek ATV), in its entirety. The Described Trail is located in Section 20 North, Township 21 North, Range 9 East, P.M.

The Described Roads and Trail are located within Valley County, Idaho, and Idaho County, Idaho and Boise Meridian.

## **PURPOSE**

The purpose of this Order is to protect public safety during an active wildfire.

## **IMPLEMENTATION**

1. This Order shall be in effect from **October 18, 2024**, at 6:00 PM through November 30, 2024, at 6:00 PM, unless rescinded.
2. A map identifying the Described Roads and Trail is attached and made part of this order as Exhibit A. A copy of this closure order will be posted on the Payette National Forest webpage at: <https://www.fs.usda.gov/main/payette/fire>, as well as social media accounts for the Payette National Forest as appropriate.
3. Unless otherwise expressly defined in this Order, the terms used in this order are defined by the regulations of the Secretary of Agriculture, 36 C.F.R. Chapter II, Parts 200-299. If there are terms in this order that are not expressly defined in the order or 36 C.F.R. Chapter II, Parts 200-299, their meaning shall be determined by their plain language definitions.
4. A violation of the above prohibitions is punishable as a Class B misdemeanor by a fine of not more than \$5,000 for individuals and \$10,000 for organizations, or by imprisonment for not more than six months, or both. 16 U.S.C. § 551; 18 U.S.C. §§ 3559, 3571, and 3581.

6. This Order supersedes Order #0412-608 or any other orders prohibiting the same or similar acts on the same Described Roads and Trail.
