### USDA FOREST SERVICE SHASTA-TRINITY NATIONAL FOREST FOREST ORDER NO. 14-24-23 SHOE FIRE CLOSURE

Pursuant to 16 U.S.C. § 551 and 36 C.F.R. § 261.50(a) and (b), and to provide for public safety, the following acts are prohibited within the Shasta-Trinity National Forest. This Order is effective from October 17, 2024, through January 31, 2025.

- Going into or being upon any National Forest System lands within the Shoe Fire Closure Area, as described in Exhibit A and shown on Exhibit B. 36 C.F.R. § 261.52(e).
- 2. Being on the National Forest System roads below, as shown on Exhibit B and listed in Exhibit D.
  - a. Any National Forest System road within the Shoe Fire Closure Area
  - b. Fender's Ferry Road, from a point 3.5 miles west of its intersection with Highway 299, then west to the boundary of the Closure Area.

36 C.F.R. § 261.54(e).

- 3. Being on any National Forest System trails within the Shoe Fire Closure Area, as listed in Exhibit D and shown on Exhibit B. 36 C.F.R. § 261.55(a).
- 4. Entering or using the following developed recreation sites, as shown on Exhibit C:
  - a. Dekkas Rock Picnic Area
  - b. Dekkas Rock Campground
  - c. Pine Point Campground
  - d. All Hirz Bay Campgrounds
  - e. Ellery Creek Campground
  - f. Moore Creek Campground

36 C.F.R. § 261.58(b).

Pursuant to 36 C.F.R. § 261.50(e), the following persons are exempt from this Order:

- 1. Persons with Forest Service Permit No. FS-7700-48 (Permit for Use of Roads, Trails, or Areas Restricted by Regulation or Order), specifically exempting them from this Order.
- 2. Any Federal, State, or local officer, or member of an organized rescue or fire- fighting force in the performance of an official duty.

These prohibitions are in addition to the general prohibitions in 36 C.F.R. Part 261, Subpart A.

A violation of these prohibitions is punishable by a fine of not more than \$5,000 for an individual or \$10,000 for an organization, or imprisonment for not more than six months, or both. 16 U.S.C. § 551 and 18 U.S.C. §§ 3559, 3571, and 3581.

- 1. The boundary of the Shoe Fire Closure Order area begins at the intersection of Forest Trail 02W08 and Section 33, Township 37 N, Range 3 W, Mount Diablo Base and Meridian (MDBM),
- 2. then continues east along the north edge of Section 33, Township 37 N, Range 3 W to its intersection with the Shasta Trinity National Forest Boundary, Section 34, Township 37 N, Range 1 W, MDBM,
- 3. then continues south along the Shasta Trinity National Forest Boundary to its intersection with the west edge of the Pit Six Reservoir, Section 20, Township 36 N, Range 1 W, MDBM,
- 4. then continues south along the west edge of Pit Six Reservoir to its intersection with the Pit Seven Reservoir, Section 5, Township 35 N, Range 1 W, MDBM,
- 5. then continues south along the west edge of the Pit Seven Reservoir to its intersection with the Shasta Trinity National Forest Boundary, Section 5, Township 35N, Range 1 W, MDBM,
- 6. then continues south along the Shasta Trinity National Forest Boundary to its intersection with the west edge of the Pit Seven Reservoir, Section 22, Township 35 N, Range 1 W, MDBM,
- 7. then continues south along the west edge of the Pit River Seven Reservoir to its intersection with Lake Shasta, Section 32, Township 34 N, Range 1 W, MDBM,
- 8. then continues west along Lake Shasta to its intersection with the south edge of Section 9, Township 34 N, Range 2 W, MDBM,
- 9. then continues east along the south edge of Section 9 to its intersection with the west edge of Section 10, Township 34 N, Range 3 W, MDBM,
- 10. then continues north along the west edge of Section 10 to its intersection with the south edge of Section 16, Township 35 N, Range 3 W, MDBM,
- 11. then continues west along the south edge of Section 16 to its intersection with Shasta Lake, Section 17, Township 35 N, Range 3 W, MDBM,
- 12. then continues north along Shasta Lake to its intersection with the McCloud Bridge / Forest Trail 02W08, Section 31, Township 36 N, Range 3 W, MDBM,
- 13. then continues north along Forest Trail 02W08 back to the starting point, as shown in Exhibit B.
