**Fire Closure**

**PROHIBITIONS**

Pursuant to 16 U.S.C. § 551 and 36 C.F.R. § 261.50(a) and (b), the following is prohibited on the National Forest System (NFS) lands and roads in the Carson Ranger District, Humboldt Toiyabe National Forest, described below and shown on the attached map incorporated into this Order as Exhibit A (the “Described Area and Roads”):

1. Going into or being upon the Described Area. 36 C.F.R. § 261.53(e)
2. Being on the Described Roads. 36 CFR § 261.54 (e)
3. Being on the Described Trail. 36 CFR § 261.55 (a)

**EXEMPTIONS**

Pursuant to 36 C.F.R. § 261.50(e), the following persons are exempt from this Order:

1. Persons with Forest Service Permit No. FS-7700-48 (Permit for Use of Roads, Trails, or Areas Restricted by Regulation or Order), specifically exempting them from this Order or a written determination by a Forest Service authorized officer that a permit is not required under 36 C.F.R. § 251.50(e)(1) or (2)].
2. Any Federal, State, or Local Officer, or member of an organized rescue or firefighting force in the performance of an official duty.
3. Federal or State administrative personnel in the performance of an official duty.
4. Residents that need to access their property.
5. County and State Roads or property do not apply to this Order.

**DESCRIBED AREA**

The Described Area and Forest Roads and Trail are located in Washoe County, NV on the Carson Ranger District, Humboldt Toiyabe National Forest.

Described Area 1:

All National Forest System Lands with the Davis Fire Boundary as shown in Exhibit A.

The Described Roads are NFS Roads 41040, 41041, and 41727.

The Described Trail is NFS 21059 (Ophir Creek Trail).

## **PURPOSE**

The purpose of this Order is to protect public health and safety during the continued efforts of a Fire Incident Management team operating in the area related to the Davis Fire, as well as follow up operations as they relate to Post fire recovery assessments.

## **IMPLEMENTATION**

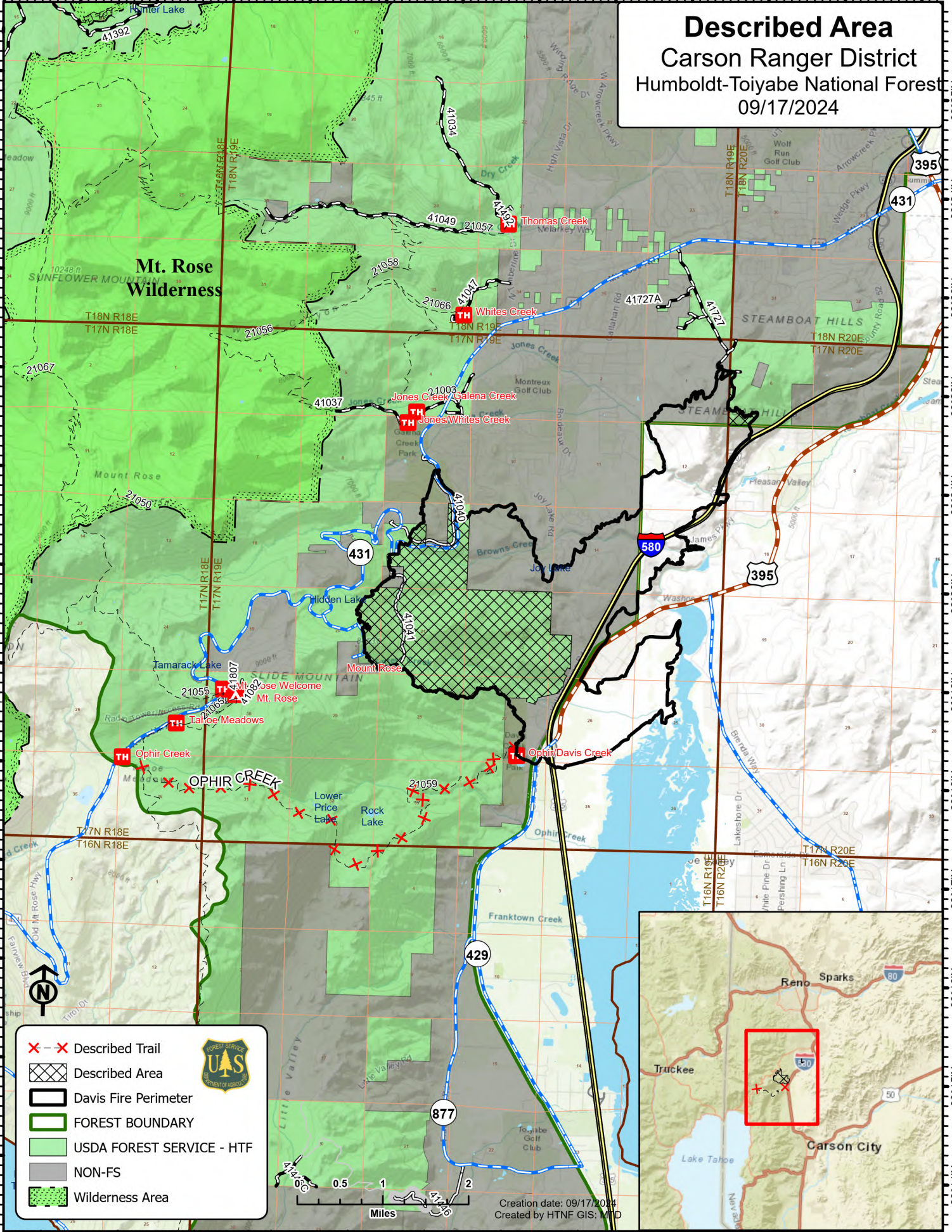
1. This Order shall be in effect from September 17th, 2024, at 12:01 am through October 31st, 2024 at 12:01 am unless rescinded.
2. A map identifying the Described Area is attached and made part of this Order as Exhibit A. For a digital version of this Order and Exhibit A, go to <https://www.fs.usda.gov/alerts/htnf/alerts-notice>.
3. Unless otherwise expressly defined in this Order, the terms used in this Order are defined by the regulations of the Secretary of Agriculture, 36 C.F.R. Chapter II, Parts 200-299. If there are terms in this Order that are not expressly defined in the Order or 36 C.F.R. Chapter II, Parts 200-299, their meaning shall be determined by their plain language definitions.
4. A violation of the above prohibitions is punishable as a Class B misdemeanor by a fine of not more than \$5,000 for individuals and \$10,000 for organizations, or by imprisonment for not more than six months, or both. 16 U.S.C. § 551; 18 U.S.C. §§ 3559, 3571, and 3581.
