Special Statement


IDAHO DEQ has issued an air quality advisory to advise residents of Lemhi County of degraded air quality. No open burn rule is in effect.

Fire

Continued success on all fires across the forecast area. Firing operations are helping to secure the fire lines and reduce large fire growth potential. Full suppression activities will continue today to prepare for incoming winds, rain, and possible snow mid-week.

Smoke

Return of blue-sky conditions for most of the Lemhi Valley today. Very light haze will continue into the late afternoon, with minimal surface level impacts. Residents and visitors in the Shoup, Colson Cr, Panther Cr, and Deep Cr drainages will not see improving conditions for most of the day. Thick smoke impacts at the surface will see limited periods of improvement throughout the day. Potential for smoke trapped in the deep drainages to begin lifting in the late evening. Locations above 7000' will enjoy clear skies all day.
