
Special Statement

IDAHO DEQ has issued an air quality advisory to advise residents of Lemhi County of degraded air quality. No open burn rule is in effect.

Fire

Today, crews will continue clearing vegetation along Blackbird Road and Deep Cr Road, while dozer line construction persists on Moyer Peak. On Ridge Road (FR 020), crews are prepared to begin controlled ignitions if necessary to prevent the fire from spreading eastward, with assessments taking place throughout the day. At the spot fire near Napias Creek, crews will remove dangerous trees and secure the containment line. The Garden Creek Fire has slowed in growth, and crews are now fortifying lines to withstand the approaching winds along the river.

Today will feel like a repeat, with high-level bands of smoke being pushed northeast across the Lemhi Valley into the Beaverhead & Bitterroot Ranges. There's a high chance of surface impacts between Carmen and North Fork, and along Highway 93 to Sula. Thankfully, in the afternoon and evening, an incoming front will bring better dispersion winds, offering some overnight relief. Hang in there- there are several waves of cold, windy, and wet weather headed into the forecast area starting Wednesday.
