# U.S. Department of Agriculture, U.S. Forest Service Manti-La Sal National Forest Moab Ranger District

## Revised Area, Roads and Trails Closure for Deer Creek Wildfire

#### **PROHIBITIONS**

Pursuant to 16 U.S.C. § 551 and 36 C.F.R. § 261.50 (a) and (b), the following are prohibited on the National Forest System (NFS) lands, roads, and trails in the Moab Ranger District, Manti-La Sal National Forest, described below and shown on the attached map incorporated into this Order as Exhibit A (the "Described Area, Roads, and Trails"):

- 1. Going into or being in the Described Area, 36 C.F.R. § 261.52(e).
- 2. Being on the Described Roads or Trails 36 C.F.R. § 261.54(a) and § 261.55(a).

#### **EXEMPTIONS**

Pursuant to 36 C.F.R. § 261.50(e), the following persons are exempt from this Order:

- 1. Persons with a special use authorization or other Forest Service authorization specifically exempting them from the effect of this Order.
- 2. Any Federal, State, or Local Officer, or member of an organized rescue or firefighting resource in the performance of an official duty.
- 3. Federal or State administrative personnel in the performance of an official duty.
- 4. Owners or lessees of land in the Described Area with an incident escort approved by the Forest Service.

#### DESCRIBED AREA/ROADS/TRAILS

The Described Area is in San Juan County, Utah and in Montrose County, CO. The Described Area is located in T27S, R26E; T28S, R25E; T28S, R26E; and T28S, R25E; Salt Lake Meridian. And T48N, R20W; T48N, R19W; T49N, R20W, T47N, R20W; New Mexico Meridian.

The Described Roads include the entirety of NFS Roads 128 (Coyote Springs), 129 (Dark Canyon Lake), 201 (Hangdog), 202 (Hop Creek), 208 (Upper Two Mile), 352 (Pine Flat – Carpenter), 358 (West Carpenter Ridge), 371 (Paradox), 373 (Carpenter Ridge), 375 (Little Buckeye), 376 (Conlay), 377 (West Buckeye), 378 (Paradox Valley), 4102, 4111, 4112, 4114, 4115, 4116, 4118, 4119, 4120, 4121, 4122, 4123, 4125, 4130, 4131, 4132, 4134, 4135, 4137, 4139, 4140, 4141, 4142, 4145, 4203, 4204, 4250, 4730, 4731, 4732, 4733, 4736, 4742, 4743, 4744, 4745, 4746, 4747, 4748, 4749, 4752, 4753, 4774, 4777, 4799, 4800, 4801, 4805, 4806, 4807, 4810, 4811, 4812, 4826, 4827.

The Described Trails include the entirety of NFS Trails #979, 980, 981, 983, 984, and 985.

The Described Campsite Recreation areas include Buckeye Recreation area.

### **PURPOSE**

The purpose of this Order is to protect public health and safety during an active wildfire and burning operations.

#### **IMPLEMENTATION**

- 1. This Order shall be in effect from July 21, 2025, at 2359 through August 15, 2025, at 0001, unless rescinded.
- 2. A map identifying the Described Area, Roads, and Trails is attached and made part of this Order as Exhibit A. For a digital version of this Order and Exhibit A, go to https://www.fs.usda.gov/r04/manti-lasal/alerts
- 3. Unless otherwise expressly defined in this Order, the terms used in this Order are defined by the regulations of the Secretary of Agriculture, 36 C.F.R. Chapter II, Parts 200-299. If there are terms in this Order that are not expressly defined in the Order or 36 C.F.R. Chapter II, Parts 200-299, their meaning shall be determined by their plain language definitions.
- 4. A violation of the above prohibitions is punishable as a Class B misdemeanor by a fine of not more than \$5,000 for individuals and \$10,000 for organizations, or by imprisonment for not more than six months, or both. 16 U.S.C. § 551; 18 U.S.C. §§ 3559, 3571, and 3581.

6. This Order supersedes Order 04-10-25-04-01, which is rescinded by this Order.
