**Current Situation:** Yesterday, scattered showers spread across Pine Valley. Wildland fire crews continue to secure the southern edge of the fire, east and west of Deer Flat. Crews are putting line around needed areas and any existing lines that need reinforcement. They are also completing suppression repair on the Brown's Point Trail. There has been no fire growth in the past 24 hours. Aviation resources are being used to survey and identify heat sources for firefighters to address other portions of the fire. Firefighters are stationed in the Oak Grove area, prepared to respond to any increases in fire activity. Crews in the Pine Valley community will remain to provide support as needed.

**Weather and Fire Behavior:** Today begins a drying trend, continuing through the remainder of the week. South southwest winds are expected, gusting 20 mph. Pine Valley and surrounding areas will be dry until the next round of moisture moves into the area toward the end of the month.

**Evacuations and Closures:** Stage 1 fire restrictions remain in Washington, Iron, and surrounding counties. A Forest Closure Order is in place for the Pine Valley Ranger District; information can be found on the Dixie National Forest website. The communities of Pine Valley, Grass Valley, and Gray's Ranch are now in "Ready" level evacuation status, and Pinto is no longer in any evacuation status. **Special Notes:** Color Country Type 3 Team is coordinating closely with the Dixie National Forest, State of Utah Forestry, Fire and State Lands, Bureau of Land Management, and local cooperators to meet the needs of the changing fire conditions. Wildfires are a No Drone Zone. If you fly, we can't. Every time a drone is spotted near the fire all aircraft are grounded until we can be sure the drone is clear of this area.
