Fire management integration and transition from California Complex Incident Management Team 3 to the Shasta-Trinity National Forest Type 3 organization has begun. This integration provides a smooth and seamless transition and transfer of command. Transfer of Command will be at 7:00 PM this evening.

The priority remains full suppression and containment of the fire. The restoration process starting with suppression repair to bring the forest back to a productive and vibrant resource is a component of this strategy. A Forest Service Burned Area Emergency Response (BAER) team has been established by the Shasta-Trinity National Forest to assess post-fire impacts. The team is conducting a rapid assessment to identify immediate post-fire threats to life, property, water quality, and critical natural and cultural resources. The BAER team is evaluating the increased risks of flooding, debris flows, and erosion.

The removal of fire suppression equipment is nearing completion. This includes mechanized equipment such as dozers, chippers and excavators. These large pieces of equipment are using local roads. Residence needs be alert of this traffic.

Fire Resources: 321 personnel

Fire Activity: Previous prescribed fire activity and wetting rain has moderated fire behavior on the Southwest portion of the fire. Despite warmer and drier weather, the vegetation and ground fuels still aren't as dry as they were earlier in July. Fire activity remains very low, with smoldering well within the fire's perimeter.

Fire Weather: Storm chances will drop to around 10% on Saturday, with most storms staying farther away from the fire. Another wave of thunderstorms is likely to arrive on Sunday as tropical moisture moves into the region, before drier and hotter weather takes over early next week.

Evacuations: At 10:00 AM on Saturday, August 2, 2025, the Shasta County Sheriff's Office reduced the Evacuation WARNINGS for ALL zones. All Zones have now returned to a NORMAL status.
